SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. - 3. In the space provided below, please describe the extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.**

The Argyle Central School District is committed to safely reopening the district and sustaining the safe daily operations, while at the same time meeting the academic, social, and emotional needs of our students, faculty, and staff. As part of our plan, we intend to allocate funds to: accelerate learning, mitigate learning loss, and to providing opportunities to safely return students to in-person instruction while maximizing instructional time. Specifically, these funds will be utilized in a variety of ways including employing an elementary teacher, a reading teacher, and a permanent substitute teacher to allow the district to re-institute reading services PreK-Grade 3 (Reading Teacher), continue operating with reduced class sizes (Elementary Teacher), and provide a consistent option for coverage when teachers are absent from school (Perm. Sub).

In addition, the district will use funding to employ an additional bus driver as a way to ensure students are able to be transported to and from school while meeting social distancing guidelines to the extent possible.

Funding was also allocated to add .2FTE to the Occupational Therapist's schedule. This time will allow our OT to work with students in grades K, 1, and 2 who were negatively impacted by a lack of in-person instruction and/or OT services that occurred since March 2020.

The district also allocated funding for a school counselor to focus on the social, emotional, and academic needs of our K-8 students and families. This addition will also allow our Jr/Sr High guidance counselor to better address individual needs of our students in grades 9-12. The district is also increasing counseling services by adding a second .5 FTE provider through Norther Rivers to address the counseling needs of students and their families.

A portion of the funds will also be used to cover the cost of upgrading the district's HVAC filters, transitioning from MERV 8 to MERV 11 (the maximum filter recommended for our current HVAC system).

A portion of these funds will also be allocated to replace and upgrade our smartboards in the Elementary school. This upgrade will better allow our teachers and students to utilize technology, both in the classroom and remotely (should it be required), this will allow the district to better address learning loss and meet the needs of all our students. A portion is also allocated to continue transitioning our library into a dynamic media center learning space, a requirement brought on by the pandemic. Specifically, allocations for the media center learning space are earmarked for tables, chairs, and desks required to properly equip the space to meet the needs of our students in both elementary and jr/sr high school.

Additionally, we are looking to implement evidence-based strategies to meet students' social, emotional, mental health, and academic needs and offering extended learning and enrichment opportunities after school hours and over the summer.

The Argyle CSD has established a comprehensive, data-driven program for assessing and diagnosing the specific academic and social emotional needs of our students. The district uses/will use the findings and results of these assessments to identify students who are performing at, above, or below grade level; our staff then meets to develop and implement specific learning plans based on student need and designed to provide instruction and/or remediation to assist students in meeting established local, state, and federal standards. The district administers iReady Reading and Math assessments to all K-8 students a minimum of three times per year (fall, winter, and spring) and student results are analyzed by Administrators, Teachers, and Support providers during scheduled data review and grade level meetings. The Fall administration serves as the student's benchmarking exam and is compared against the student's previous assessment results and performance on NYS assessment (if applicable). Students performing at or above grade level are progress monitored again in the winter and the spring. Students identified as performing below grade level on the iReady assessments are reviewed by a team consisting of classroom teachers, administration, support and special education teachers. The team identifies specific area of weakness, develops a plan for remediation (which may range from differentiating with in the classroom, social-emotional support, and/or supplementing classroom instruction with additional support and instruction provided through identified intervention periods). Students receiving additional services are monitored on a more frequent basis (ranging from increments of 2-6 weeks) and instruction/additional support is developed/provided in response to student performance. Over the course of the school year, students who benchmarked as meeting or exceeding grade level performance who demonstrate regression are reviewed and if necessary, included in the remediation efforts as described above, afterschool/extended school day instruction, and/or summer enrichment. The programs are research-based and based on the established learning standards.

The Argyle Central School District will reserve at least 20% of our funds to address the academic impact of lost instructional time by providing opportunities for summer school programming for students, expanding our credit recovery program for students in grades 9-12, extending our after-school and enrichment programming, and hiring additional instructional staff.

Specifically, at the Jr/Sr High level, the district will use funding to support students in enrolling in regional summer school sponsored by Argyle CSD, BOCES, or other local districts. This funding will include transportation costs and tuition costs of the program. In addition, in the case that academic specific programming is not available for summer school, students will be afforded the opportunity to participate in credit recovery programming, either through in-person instruction or through an accredited on-line learning platform.

Argyle elementary school will utilize funding to support students in enrolling in regional summer school and summer enrichment activities sponsored by Argyle CSD, BOCES, or other local districts. This funding will include transportation costs and tuition costs of the program.

Aside from the reserved funds for addressing learning loss, the district will be allocating funds to address the impacts of the COVID-19 pandemic on students, implementing strategies to meet the students' social, emotional, mental health, and academic needs. Specifically, this will include allocating funding to hire a K-8 guidance counselor to work with students, families, faculty and staff to better identify and address academic, social, and emotional needs and add additional social, emotional, and mental healthy counseling and support through the addition of a .5 counselor through Northern Rivers. The district's current occupational therapist will be increased by .2 FTE (one day a week) to address learning loss in grades pre-k through 2. Several of these students have not received direct support and we are observing the need to provide support in the areas of hand writing, dexterity exercises, and other visual, sensory, and physical capabilities.

The district uses/will use the findings and results of these assessments to identify students who are performing at, above, or below grade level; our staff then meets to develop and implement specific learning plans based on student need and designed to provide instruction and/or remediation to assist students in meeting established local, state, and federal standards. The district administers iReady Reading and Math assessments to all K-8 students a minimum of three times per year (fall, winter, and spring) and student results are analyzed by Administrators, Teachers, and Support providers during scheduled data review and grade level meetings. Over the course of the school year, students who benchmarked as meeting or exceeding grade level performance who demonstrate regression are reviewed and if necessary, included in the remediation efforts as described above, afterschool/extended school day instruction, and/or summer enrichment.
